

from CD case labels to temporary appliance labels. Covinax 210 also is FDA compliant for use
with most food and drug packaging, under the following regulations: 21 CFR 175.105, 21 CFR
176.170, 21 CFR 176.180, 16 CFR 1500.3(C)(2)(i) and 16 CFR 1500.3(C)(4).

In addition to its clarity, Covinax 210 stands out for its durability over the long term. It maintains constant, smooth peel adhesion with clean removability, even after extended aging.
